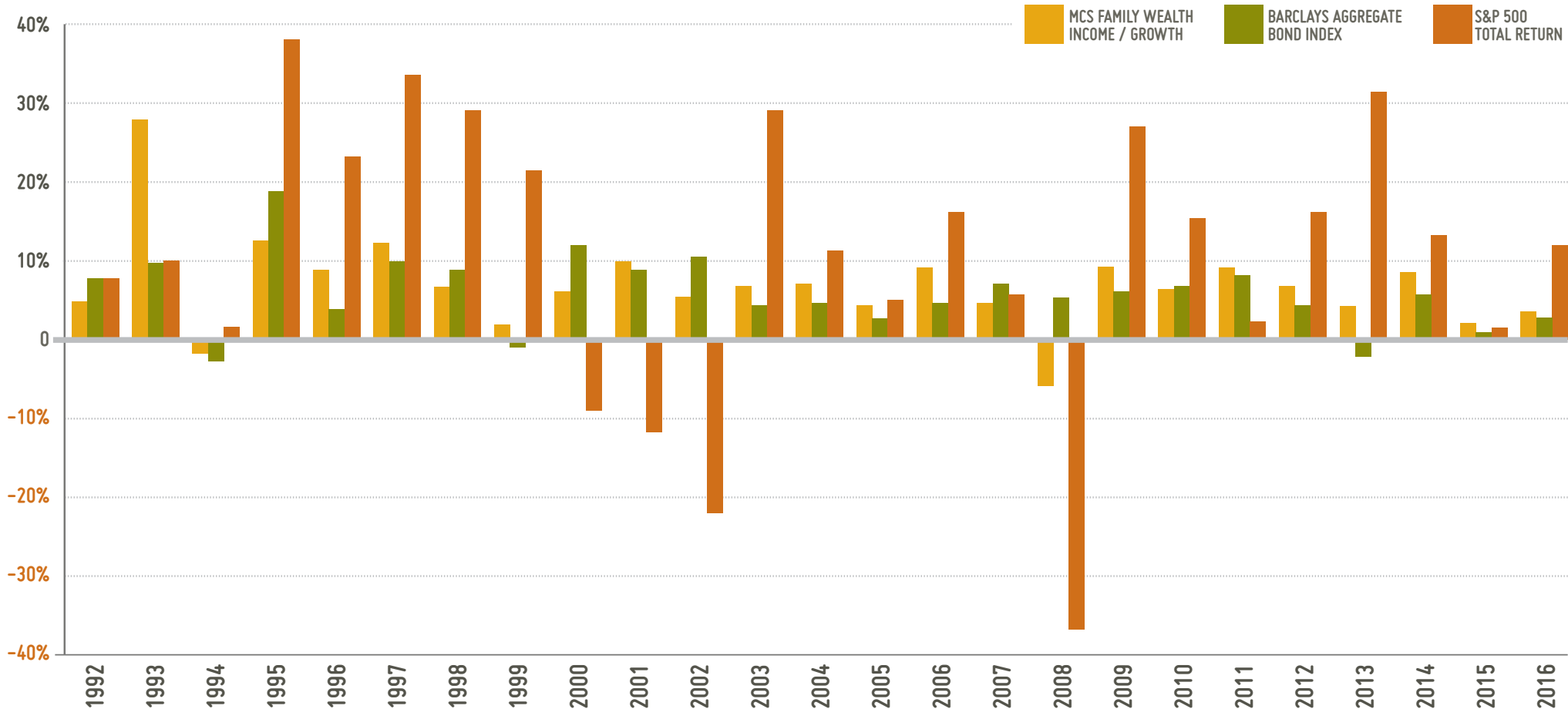

These accounts represent 97% of MCS's discretionary assets under management as of 12/31/2016 and were invested primarily in US stocks and bonds (17% of client assets on 12/31/2016 were invested in tax-exempt municipal bonds). The Stock Index values are based on the S&P 500 Total Return Index, which measures the large-capitalization US equity market. The Bond Index values are based on the Barclays Capital US Aggregate Bond Index, which measures the US investment-grade bond market. Index values are for comparison purposes only.
